## **LOLICON - A BRIEF GUIDE**

Have you ever been masturbating furiously to Rikka being gangbanged, Kanade being split in two by a colossal cock, or any other number of fantastic things and thought, "I wonder if I'm breaking any laws"? Well wonder no more, friends!

You see, there's not really an 'across the board' law for lolicon content, and as such laws vary greatly by state and province. There are many misconceptions as well, but that's a topic for another day. The map to the right gives us a brief idea on where lolicon is legal in North America. The guide below this bit of text explains further...

Blue represents that lolicon is completely legal. You can own dakimakura covers, import every doujinshi, and masturbate until you have no cum left - all without consequence!

Green tells us that lolicon is legal, but with exceptions. As an example, in Canada it's only illegal to import physical media, whereas it's perfectly legal to buy locally produced content, view digital content, and so on. In the USA, certain states have the same rules on lolicon as Canada, while others require the lolis to be at least 18, among other things.

In the area coloured Yellow, lolicon is to be considered illegal, but with exceptions. For example, all forms may be illegal, but the law is rarely enforced or even known of! This is a risky area as well, because in some cases, legality depends on the bylaws in place in the area - a very local level.

Finally, in the Red area, lolicon is completely illegal. There are no bylaws to make it legal, the law is generally enforced, and even looking at pictures posted online could potentially get you thrown in prison. This is a high risk zone.

So there you have it! There is, of course, more to it than this, but you can only get so much information across with a chart.

The basis for the ruling was that the CPPA made unlawful some forms of protected First Amendment specin, such as panning depictions of sex between children, even if not obscene and not involving real child victims.
